BOARD MEETING CHANGE

The monthly board meeting has been rescheduled to September 2nd at 6:00 pm.

PALS CONSTRUCTION

District staff and conservation corps are currently busy building PALS in Tenmile Creek and Couse Creek. Post Assisted Log Structures (PALS) are hand-built structures that mimic the processes of wood accumulation. Woody materials of various sizes are pinned together with untreated wood posts and driven into the substrate. The purpose these structures are to improve fish habitat and water quality. The goals of the project areas are to increase floodplain access, water/sediment retention, instream complexity, and facilitate replanting of riparian trees and shrubs.

WILDFIRE RECOVERY

On July 7th, the Silcott, Dry Gulch and Lick Creek fires simultaneously erupted from lightning in Asotin County. We know many landowners were affected significantly by the fire's destruction. If you have had a loss to your property, please contact us about opportunities that are available for assistance. ACCD staff currently has boots on the ground conducting evaluations.

MANURE MANAGEMENT

ACCD is currently taking applications for manure management projects. Anyone interested in cost-share for feed pads and manure containment structures should contact the District for more information. Applications must be received by <u>4:30 pm on September 24th</u> to allow time for staff to conduct site evaluations and complete project ranking. Funding recommendations will be made at the October 7th board meeting.

WEED CONTROL COST-SHARE

The Asotin County Conservation District is continuing to offer noxious weed control cost share. There are two options available, but landowners may only participate in one of the options.

- Ground application will be 50% cost-share not to exceed a payment of \$25 per acre with a cap of \$250 per landowner. Landowners may do the work themselves or hire a contractor to do the spraying. (See the ACCD Contractor's List for licensed contractors in the area, other licensed contractors may be used as well.)
- Aerial applications will be 50% cost-share not to exceed a payment of \$37.50 per acre with a cap of \$750 per landowner.

All applicants will need to have a noxious weed management plan based on management needs. Staff is available to assist with noxious weed assessments and will create individual management plans for cooperators. Management plans will consist of short and long term weed control goals and the monitoring of weed infestations.

Now Taking Tree Orders

Each year, we find it more challenging to secure desirable tree species and stock types for projects and the annual tree sale. With wildfires raging across the western United States, it is likely the challenge will be even greater for 2022! If you are interested in purchasing trees from the District for a project or special order, please contact us as soon as possible. We will be starting to put together orders to several nurseries in this month.
