## **FUNDING OPPORTUNITY**

The Washington State Conservation Commission (WSCC) received a significant amount of funding in the FY23 supplemental budget. The funds are available to Conservation Districts in Washington state to implement best management practices that address specific resource concerns.

#### Salmon Recovery Funding - Riparian

A portion of funds in the state operating budget were appropriated to the Salmon Recovery Account. There was a funding proviso stating funds were solely for the Commission to provide grants for riparian restoration projects with landowners.

# **Voluntary Stewardship Program**

The legislature appropriated funds from the State Building Construction Account capital budget to the Voluntary Stewardship Program. Projects must be in a VSP watershed and designed to meet a county work plan goal or benchmark. The Asotin County VSP work group must approve all projects prior to submittal to WSCC.

### **Engineering & Design**

WSCC received funds to support Conservation District Engineering which has supported area engineers who provide support to multiple conservation districts in each region of Washington for several years. For FY23, additional funds were allocated to the Engineering budget. In addition to fully funding the area engineers, conservation districts can request funds to support additional engineering and design activities.

### **Funding Details**

The Asotin County Conservation District will be accepting applications for projects that fit the Salmon Recovery Funding and Voluntary Stewardship Program funding. All projects must be completed by June 30, 2023 and will require cultural resources surveys for projects that include ground disturbing activities.

### **Project Applications**

Technical staff will develop project plans for review by the ACCD Board of Supervisors. Any projects seeking VSP funds must also be approved by the Asotin County VSP Workgroup.

The ACCD Board of Supervisors will be reviewing projects in August and September to allow adequate time to complete the environmental compliance requirements and implement projects prior to the June 30, 2023 funding deadline.

Funds are available on a first come first serve basis in addition to a committee review by WSCC to confirm funding criteria is met.

#### **ENVIROTHON KITS**

Palouse Conservation District is excited to announce new community resources. Residents of Whitman, Asotin, Garfield, Columbia, Walla Walla, Spokane, Lincoln, Adams, Franklin, and Latah Counties can check out Soil Health and Envirothon kits from the PCD office.
