### WSCC TOUR

On September 20<sup>th</sup>, representatives from WSCC (WA State Conservation Commission), WACD (WA Association for Conservation Districts, NRCS (Natural Resources Conservation Service), and other Conservation Districts attended a tour of several projects. Four of ACCD's newest projects were showcased on the tour; trommel screen for manure, Cougar Creek fish passage barrier correction, a forest health thinning & pruning site, and an instream fish habitat improvement site. The goal of the tour was to showcase the natural resource benefits of completed and ongoing conservation projects to the Commissioners, WSCC Staff, and partners.

### **FOREST HEALTH & COMMUNITY WILDFIRE RESILIENCY GRANT**

The frequency and severity of wildfires in Washington, historical forest management practices, and increasing populations in rural and suburban areas make it vitally important that private landowners steward forest land for improved health and resilience and be prepared for wildfire. Improving forest health for climate and wildfire resiliency is critical at the same time as rural populations are growing and forest parcels are becoming smaller and more numerous.

ACCD is thrilled to announce we have secured funding for outreach, education, and technical and financial assistance are needed to assist new and long-time forest land managers alike to manage their forest lands for better health and wildfire resiliency.

This funding will also be used to help Asotin County get a much-needed updated CWPP (Community Wildfire Protection Plan). Landowner involvement will be a key to a successful CWPP update in 2024!
