Weather Station Locations

ACCD has purchased six new weather stations. The stations will help to fill in the data gaps when weather systems hit different parts of Asotin County. Landowners/homeowners were contacted in specific geographic areas, those who voiced interest in hosting a station will go into a drawing for a final

selection to host. Fewer landowners/homeowners in the Meyers Ridge and Grouse Flats areas voiced interest and met the criteria for hosting.

Delegation of Authority to sign CRP Conservation Plans

FSA field offices were told that Conservation Districts now must sign CRP Conservation Plans to comply with the Farm Bill. There are six current contracts in Asotin County.

Jesse Greene moved to approve, and Jerry Hendrickson seconded the motion to approve the authorization for staff to sign the Asotin County CRP Conservation Plans. **Motion Carried.** *Rod Hostetler abstained.

Staffed Crew Proposal

Since the WCC crew is no longer a suitable fit for ACCD, Megan researched recommendations for the Board to staff a crew. While there is an increased cost to staffing a crew, the benefits offset the cost greatly. The initial plan is to start the process of developing a crew by starting the search for a crew leader. If we are unable to find a good candidate, the process will not move forward, and the District will explore other options to address the workload gaps for project implementation. The board supports starting with a small crew including a leader and 2 crew members.
