- Tree of Heaven is a growing concern it is host to the spotted lantern fly
  - Kodie has created an interactive mapping tool

# **New Business:**

<u>Cost-Share Program</u> (large landowners)

- Eight applications currently approved for a total of 426 acres
- Each application is eligible for \$500

#### Weed Management Program (small landowners)

- Two landowners are currently in the process of completing full noxious weed management plans
  - These plans will establish infestation inventory over the course of three years
- One participant agreement has been approved

## **Bio Control Program**

- Tour of the bio-control center and pesticide credit course were a success
- Ordering is currently open and will remain open year-round (first come, first served)
- Ordering online via ACCD may be an option

# **EDRR Program**

- Common crupina locations have been mapped
- WCC Crew will continue assessments during the spring growing season

#### **Knotweed Program**

- A site visit was made on 3/1
  - o Little to no regeneration of knotweed
  - O A spring herbicide application is planned to treat a few remaining stalks and blackberries
- A site restoration plan is being drafted

# Mediterranean Sage Program

- WDFW treated the mapped infestations on Meyers Ridge on April 1st
- Kodie is exploring a couple funding options
  - The RMEF regional committee recommended the Med. Sage treatment funding request be fulfilled. The national committee needs to review the request but will likely be approved in May.
  - O A funding request for the Mule Deer Foundation is currently being drafted. MDF accepts applications year-round.

### **USFS Invasive Plant Partnership**

- Working with forest service staff to establish treatment areas for spring control on Lick Creek
- WCC crew will begin herbicide applications in the Lick Creek area mid-May
- Cottonwood Gulch is next on the list for treatment

#### Outreach

- ACNWCB and ACCD will have a booth at the Asotin County Fair on April 26th to the 28th
- ACNWCB was selected to receive a free boot brush station sponsored by the Washington Invasive Species Council! It will be installed at the North Fork access/parking area.
- Working with WDFW on boot brush station locations and ordering materials for additional stations.
- Planning an outreach event for landscapers and nurseries.
- Planning a weed tour combined with a biological control collection and release demonstration.
