Med Sage Ground Weed Control Contractor

CREP Status Update

Asotin County has two contracts that did not require additional review during the audit. One contract was reviewed and did not require any changes. Of the remaining contracts, five conservation plan amendments will be presented to the ACCD board for approval today. The rest of the contracts were either terminated by FSA or the contract holder opted to not accept the modifications to the contract. At this time, there will be 8 contracts remaining in Asotin County.

The board directed Megan to draft two letters – one regarding the CREP Audit and the other outlining future expectations for ACCD to approve conservation plans.
